Values to Platinum Corporate Member - stay connected with the Mainland of China and Global Quality Management Professionals

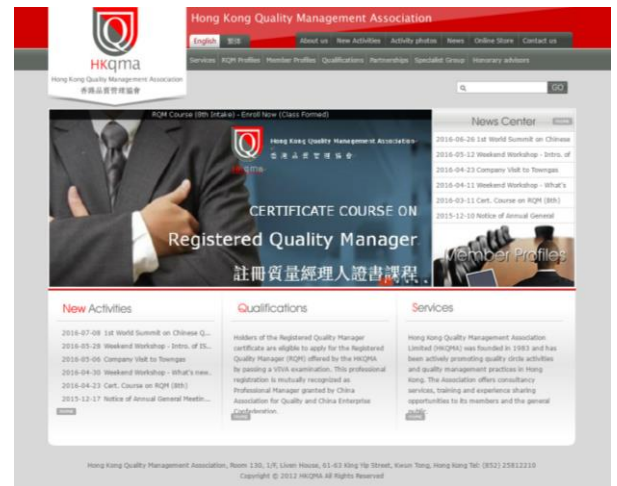
As a Hong Kong-based professional quality association, HKQMA has close link with quality associations in other parts of the world and the Mainland of China such as the **China Association for Quality (CAQ)** (中國質量協會). CAQ organizes an Annual Quality Convention called **China National Quality Circle Convention (CNQCC)** to promote the quality management culture and best practices in Greater China.

Supported by the Government, Quality Circle (QC) activities are well established in China since 1978. Over the past 37 years, QC activities are widely spread from manufacturing to service sectors such as utilities, transportation, project construction, commerce, banking, post & telecommunication, etc. At present more than 1.5 million circles were registered with over 15 million people participating in QC activities. The cumulative economic return produced by QC activities reached RMB\$410 billion. The Convention attracted quality professionals / pioneers and QC teams from various provinces and cities of China.

As the Convention will take place around September to October each year and will invite HKQMA to nominate teams to give either paper or QC/WIT (Work Improvement Team) project presentation at the Convention, **HKQMA's Platinum Corporate Members will have the priority and opportunity to represent Hong Kong to participate in the CNQCC as audience or/and presenters.** Besides, local QC sharing activities may also be organized among **Platinum Corporate Members**.

Professional Development – Registered Quality Manager (RQM)

In 2008, the Association commences to introduce a professional registration scheme as **Registered Quality Manager (RQM)** to ascertain the professionalism of the quality manager with proficient academic background and experience on Quality Management. This professional qualification is mutually recognized as **Professional Manager granted by China Association for Quality and China Enterprise Confederation**.
